
Pictured here is your Christmas present from Uncle Sam which all of you have received by now and have probably put aside in that special spot where all important papers go.

Chicago priest rescues two people from fire

The Rev. John Savukynas, a member of the Marians of the Immaculate Conception and a priest in residence at St. Mary's Church in Plano, Ill., is credited with saving two people from dying in a house fire in the Chicago area.

Father Savuknas is formerly from the Greater Pittston area of Pa, and visits the area annually. During his yearly visit he says a daily Mass at St. Casimir's Church in Pittston.

It's not the first time that Father Savukynas has been a hero. Seventeen years ago, he pulled people from a burning car after a highway accident.

On Nov. 8, Father was taking an early morning walk before the 8:30 a.m. Mass and his quick thinking may have saved the lives of two people, a mother and one of her children.

Alerted by an unidentified woman that a near-by house was on fire he ran to the rectory to tell the secretary to call the fire department then he and the woman rushed to the house to see what they could do.

He found a woman screaming hysterically in her bedroom window and she broke the window and pushed her 3-year old son through to safety in his arms. Another man arrived on the scene and broke the divider in the window to let the woman fit through. She was cut by the glass as they pulled her through.

A 6-year old and 3-year old both boys died inside the house from the smoke and heat. Firemen who arrived on the scene were unable to save them.

Things could have been even more tragic without Father Savukynas. According to the fire chief, the 6-year old would have been a goner if Father Savukynas didn't make the call.

Nakus has high hopes, deep skepticism

In a special Washington report to the New York Times, Victor A. Nakus, manager of the Washington Office of the Lithuanian Information Center, was quoted as saying he was "delighted" by the news of the return of the Cathedral in Vilinius to the Catholic Church for religious use.

However he expressed skepticism as to whether the people of Lithuania will be able to keep these new freedoms.

A state department official was quoted as stating it is easy to give back a church or give permission to fly a flag, but questions who will have the power to make decisions.

He pointed out that it is not clear that any real power has

In a special Washington reto the New York Times, to the Baltic republics.

Mr. Nakus noted that Americans of Lithuanian decent hoped for total independence of Lithuania as a long term goal but he personally hoped for Lithuania having as much freedom as Poland, pointing out that this would halt "Russification" of Lithuania.

The New York Times article quotes Nakus as saying he doesn't see the changes in the Baltic States as a hoax.

He pointed out that you don't allow this much self-expression nor do you allow these pent-up feelings of nationalism out if you're not sincere about allowing more local control.

Memory of LCA member could save 8,000 lives

The memory of the late Stanley W. Berulis, a former member of the Lithuanian Catholic Alliance, may save the lives of 8,000 third world children.

Berulis, a former member of West Pittston, Pa. who moved to the Harrisburg area was posthumously awarded the Paul Harris Fellow Award, the highest award given by Rotary International.

His wife, Nell Berulis, a Scranton, Pa. native accepted the award during the Harrisburg Rotary Club's weekly meeting.

The award was the result of the gifts of his friends and family raised for the Rotary's Polio Plus

The memory of the late Stanley program during Berulis' funeral W. Berulis, a former member of services.

The 77 year old Berulis, who died in June of 1988, suffered a handicap since he was afflicted with polio when he was one year old. Following his death, his widow remembered a story in a Harrisburg newspaper about the Polio Plus program. She suggested memorial contributions from friends and family be directed to the program.

The contributions totaled \$1,000 an amount officials say is sufficient to immunize 8,000 children in Third World countries.

Annual Board

The Lithuanian Catholic Alliance Board of Director's met at the Home Office September 15-16, 1988 with the following officers in attendance:

Msgr. Frank L. Yashkas, Thomas E. Mack, Esq., Frank J. Katilus, Charles A Liscosky Leocadia Donarovich, Rosalie Kizis, George Saduckas.

Excused were:

Joseph A. Stankaitis, MD, Albina Poska, Leonard Mikelonis, Jonas Vainius.

Following an opening prayer by Msgr. Yashkas, President Thomas Mack welcomed all to the meeting and then called for Msgr. Yashkas' report.

Msgr. Yashkas noted he was in touch with Msgr. Balkunas who is presently in the Matalaitis Nursing Home, Putnam, Conn. where he is able to receive needed care.

Msgr. Balkunas was very happy to receive the call and to know that he is not forgotten.

President Mack requested Msgr. Yashkas to prepare a short message on behalf of the LCA and mail it to Msgr. Balkunas which he agreed to do.

President Mack then gave his report noting this was the 102nd annual meeting of the Board of Directors.

He pointed out that the people of Wyoming Valley were made aware that Garsas is a national newspaper. This came about when Mrs. Eckert arranged to have several interviews with the local media managing to get very good coverage.

He noted the Garsas has become more interesting with warm and human articles focusing on the lives and activities of our members and their friends and stated Mrs. Eckert would give a report later in the meeting.

President Mack stated the common goals of all fraternal organizations are solvency, growth and services to membership, our current solvency is 169 percent which is well above the 1987 average taken of some 20

fraternal societies.

Our certificates in force have decreased however we are hopeful the new single premium policy will help us realize an increase.

He reported we are in excellent financial condition with a stable surplus. He pointed out that with the adoption of the 1980 CSO table we should see an improvement in our insurance in force and gain memberships.

Mr. Mack noted the Lithuanian Day Committee that operated for about 70 years near Hometown at the Lakewood Park and then moved to Rocky Glen was not able to hold it's annual day there this year due to the closing of the park. It was held August 14, at the Fairlane Mall south of St. Clair, Pa.

He pointed out that he was pleased to see that Governor Robert Casey of Pa. is aware of the contributions of the ethnic groups to the development and growth of the commonwealth of Pa.

In view of this, the Governor signed an executive order in May of 1988 establishing the Pennsylvania Heritage Affairs Commission to advise the Governor on many things connected with the various ethnic organizations, institutions and groups throughout the Commonwealth.

President Mack was proud to announce that another milestone was reached for our society when on May 2, 1988 the mortgage taken out in 1973 with the Small business Administration was satisfied of record in the county courthouse.

President Mack noted the Lithuanian Roman Catholic Women's Alliance is in the stages of liquidation, so it appears there will be no merger of their insurance paying members with us.

He noted that as usual we had a number of small legal matters that we were able to successfully put to rest without any litigation or costs. One of our Spiritual Directors
Monsignor John Balkunas celebrated his 85th birthday, October
21, 1987. A number of our
members were there to join with
him on this festive occasion.
Everyone was pleased with the
Monsignor's good health and
wished him many more years.

Mr. Mack expressed happiness in having our Treasurer, Leocadia back after her surgery and noted she was able to attend her son's wedding however the operation prevented her from traveling to Poland to be with her daughter when she was presented with honors there.

The President noted that most of the Board members attended the special affair held at St. Mary's Center in Scranton, Pa. marking the 25th anniversary of St. Mary's Villa Nursing Home addition. The Bishop of the Scranton Diocese James C. Timlin, was a special guest. His excellency offered remarks and gave Benediction.

Mr. Mack reminded the Board that the Lithuanian Catholic Alliance and the Lithuanian Priests Federation were the two groups that encouraged Father Alfonses Urbanavicius to form the religious congregation of the Poor Sisters of Jesus Crucified which he did with our help. He then called for a report on KASA and in view of the fact that Jonas Vainius was excused due to an earlier commitment, Mr. Liscosky briefly reviewed a letter he sent to the credit union.

Mr. Zemaitaitis telephoned Mr. Liscosky in response to his letter noting the Credit Union had purchased an old Masonic Temple and were in the process of remodeling the structure to accommodate the Credit Union offices. He was then to leave for Germany to celebrate his wedding anniversary. The Board took no action on this matter at this time.

President Mack then called on Mr. Liscosky to explain the new membership application and new premiums. Each Board member was given a prepared copy of the applications and the new premium manual.

It was properly moved and seconded to accept the President's report.

Vice-President, Frank J. Katilus reported his duties are not much due to the fact that we have at our helm an energetic individual in the person of Mr. Thomas Mack. However he noted he tries to do his share and attends all meetings of the Executive Committee sharing in all the discussions.

Mr. Katilus noted he attended meetings of the Northeastern Fraternals Association and the Lithuanian Day celebration in St. Clair which he pointed out did not compare to the days at Rocky Glen Park. He was dissapointed that there was no Mass held however he noted the attendance was good and a fine program was rendered.

Mr. Katilus expressed his appreciation to Msgr. Yashkas, Mr. Mack, Mr. Liscosky and the personnel at the Home Office for the cooperation he received throughout the year whenever it was needed.

It was properly moved and seconded to accept the Vice-President's report.

Mr. Liscosky gave a report on the office of Secretary of the Board and Executive Director the two offices he fills.

He noted he had been instructed by the Board to hold an Executive session with Mr. George Schaumann of CPS Actuaries. At this meeting it was agreed to make the necessary changes to conform with the Easy Read Language Contracts Law and the new 1980 CSO Mortality Tables. By June 1, 1988 Mr. Schaumann completed the changes and mailed them to the States Insurance Commissioners. At this time we are awaiting their response, Mr. Liscosky said.

One delinquent mortgage was turned over to our legal office for collection.

Mr. Liscosky gave a favorable report on the Home Office and staff noting that the annual state reports were prepared and mailed before the deadline. Due to the many changes in the Insurance Laws, additional reports were required by several of the states.

The Executive Director stated it is no secret that our membership roles continue to dwindle and we look to the new policies to improve this situation.

Lodge 29 in Chicago lost its secretary, Dr. Vladas Simaitis who died and Director Albina Poska graciously agreed to fill this vacancy.

Mr Adolph Paleckis, Secretary of Lodge 44 St. Petersburg, Florida resigned due to ill health as did Mr. Bronius Bobelis secretary of Lodges 115 & 135 Brooklyn, NY.

Mr. Liscosky stated it was nice to note for a change that complimentary cards, letters, and telephone calls were received from the membership stating they were happy to read the English Garsas and to be made aware of what is going on in Lithuania.

The CPS Actuaries report was read by Mr. Liscosky noting the Society's valuation indicated that based on the American Experience Standard Industrial and American Men Ultimate Tables of Mortality, with interest at 3%, the future assessments of the Society at the net rates then being collected, together with the admitted assets as they appeared in the Society's 1987 Annual Statement, were sufficient to meet all certificates as they mature by their terms with a margin of safety above the statutory standards.

A report on membership transactions shows 10 new certificates, 32 Accident and Health claims, 24 Cash Surrenders, 66 deaths reported 38 Endowments matured, 11 active Certificate Loans and 4 Trust Funds.

Age 80 plus exemptions show we began the year with 269 on the list. Another 34 members become eligible during 1988. As of date 5 exemptions were lost through death, 3 upon reaching age 96, with 2 matured endowments at age 85, and 5 became fully paid up at age 85.

In reviewing our sick benefits files we find 124 still paying.

Letters of explanation were sent to each of the 124 members giving an accounting of the number of days they had used at the number remaining to their credit. It was pointed out that they were free to drop this coverage if they weren't interested in continuing and their dues would be adjusted accordingly. Of the 124, 18 selected to drop the coverage and 10 presented claims for payment.

Mr. Liscosky noted there are still some undelivered dividend checks due to lack of address. Efforts continue to try to locate these people to clear up this backlog before the next Insurance Department examination. We continue to receive calls from members claiming they never received a dividend. When given copies of their cancelled checks we receive no further comment.

Regarding correspondence, Mr. Liscosky pointed out that members often come across Membership certificates of long deceased relatives. Our office is contacted to determine the status of the certificate which involves time-consuming research.

Death claim correspondence gets heavy when the beneficiary predeceases the insured member and no new beneficiary has been named. This requires additional documents and if we enumerate 5 items, we can look forward to writing at least 4 more letters, one for each item. the same applies to Change of Beneficiary, Cash Surrender, and Matured

Endowments, each of which requires the appropriate form to be accompanied by Membership Certificate, 90% of the time the form is returned without the certificate or vice versa.

We are presently licensed to do business in 9 states.

In his report Mr. Liscosky noted that we continue to receive inquiries about Scholarships. He pointed out that our records reveal that out of 5 who received scholarships in 1975, 3 terminated - 2 by maturity of endowments, and 1 by cash surrender. The cash surrender reenrolled 4 years later. Of the 5 who received scholarships in 1978, 1 cash surrendered, another lapsed after paying dues for only 1 year.

Reporting on the home office he noted that windows were replaced on two occasions this past year. Two windows broken by vandals on December 14. 1987 and another on June 19, 1988 caused by a break-in. At the time of the break-in the office was entered and ransacked. Fortunately there was no other physical damage, but all desk drawers were emptied and their contents strewn about the desks and floor. Since no small change or small office equipment was taken the police concluded the person must have been looking for the combination to the vault.

A frightening aspect of the break-in was the discovery of a burning cigarette left on top of one desk with papers nearby and another on top of a file cabinet between two cardboard file boxes. This incident prompted us to move all records kept in the front office files to the vault for safety. Upon authorization of our Treasurer, additional file cabinets were purchased.

Mr Liscosky noted we are encountering trouble with the heating system which was installed when the Home Office was built. In 1988 we spent \$1066.81 for repairs and further repairs are needed. Moreover, we are unsure of future service

and approximate cost because the Steam Heat Authority which furnishes our heat is going into bankruptcy.

The air conditioner is still the original equipment which survived the flood of 1972. Problems this summer cost \$167.95 over the annual service contract fee of \$200.

The addressograph and Graphotype machines also survived the flood and are serviced at an annual cost of \$608.12.

Mr. Liscosky listed several annual events he took part in as a representative of the Lithuanian Catholic Alliance.

It was properly moved and seconded to accept the report of the Executive Director.

Treasurer Leocadia Donarovich presented her report which was filed with the minutes. It was properly moved and seconded to accept the report of the Treasurer.

Trustees Rosalie Kizis and George Sadauckas presented their report noting they had made a thorough review of the records of the Executive Director and the Treasurer, including canceled checks, bank books, bank statements, bonds, securities and mortgages.

They found two delinquent mortgages which are being properly handled.

Both Trustees thanked the Executive Director, the Treasurer, and Office personnel for their time and cooperation in enabling them to fulfill their duties.

Mr. Sadauckas reported he had attended several activities during the year as a representative of the Alliance.

It was properly moved and seconded to accept the report of the Trustee's

Actuaries in the restructuring and modernization of the application forms for the Alliance in order that they might be updated and in compliance with the various state statues and regulations. The outcome of these efforts appears to have been successful.

Dr. Stankaitis noted he reviewed 11 new memberships and 35 Disability Forms.

He pointed out that in reviewing the actuaries proposed changes of the Alliance's By-Laws, most of the changes appear to be in order. "Nevertheless, I do believe that the change proposed in Article 3. Section 1 that deals with religious belief, specifically "practicing the Roman Catholic Faith" has some potential fundamental ramifications for our organization. I assume that the rationale for this change is the thought that such a qualification for membership might be discriminatory in nature. I would most certainly value the opinion of our legal counsel regarding this matter. If indeed this qualification is in violation of the law, than we are forced to change this. On the other hand, if it is viewed as not discriminatory in nature, then we run the risk of abandoning a significant part of our organizational identity, that which distinguishes our fraternal organization from the "other" Lithuanian Alliance, or for that matter, even some generic mutual insurance corporations. I caution the board to carefully consider this matter in its deliberations."

It was properly moved and seconded to accept the report of the Medical Examiner.

Although Board member Albina Poska was not able to attend the meeting, she sent in her report.

Mrs. Poska noted that although she was authorized to attend the Lithuanian Catholic Women's Alliance convention

in Chicago, she was unable to do Director Jonas Vainius. so due to an accident that hospitalized her just a few days before the convention. She did, however contact the Alliance Editor to extend greetings from the Lithuanian Catholic Alliance on her behalf which the Editor, Dale Murray did.

Mrs. Poska noted she represented the Alliance at the meeting of the Lithuanian Council (Taryba), October 17, 1987 at which time Dr. Vladas Simaitis was bestowed an honorary membership for his many years of labor for the council. Mrs. Irene Blinstrubas was selected by Council to fill his chair.

Mrs Poska reported that she wrote two articles this past year,

"Draugas" and one for the "Garsas."

She kept personal contact with the Home Office and personally remembered some members in their illness, anniversary, and condolence. Some with Mass offerings.

Mrs. Poska noted she gained a sense of satisfaction in being able to save 7 members (from 2 families) from being dropped from the membership. She says that contact with member's parents or grandparents is helpful in keeping their offspring in good standing.

It was properly moved and seconded to accept the report of Director Albina Poska.

Director Jonas Vainius who was excused sent in his report.

In his report he noted he met with the Officers of the Lithuanian Credit Union, "KASA" for the purpose of investigating whether there would be a mutual interest in developing an operational relationship. LCA's Executive Committee has extended an invitation to the Credit Union for preliminary discussions at the LCA Home Office. It was properly moved and seconded to accept the report of

Frances Laucka Domanskis sent in a report from the Lithuanian Catholic Alliance Foundation which was read and accepted.

Mr. Liscosky referred to his annual report and informed the Board that Mr. Adloph Paleckis, Petersburg, Florida, resigned due to illness. The Alliance presently has no active Lodge in Florida and this could present a problem if the convention were to be held there with no Lodge to handle the on-site details.

President Mack read a letter received from Mr. Stasys Garliauskas, a member of the Alliance and a delegate to previous Conventions. Mr. Garliauskas lives in Michigan and expressed concern about the convention being held in Florida due to the expense it would require to travel this distance. In his letter he suggested the Board consider Baltimore, Maryland since it was accessible from all points.

Mr. Mack suggested this topic be discussed at lunch since it was time for that break.

The Meeting was adjourned at 12:20 p.m.

The second session of the Board of Directors meeting resumed at 2:05 p.m. with Vice President Frank J. Katilus presiding. Mr. Mack was detained and would arrive a bit later.

The Vice President reviewed the actions of the First Session and then called for the Accountant's Report.

The accountant's report noted the increase costs of licensing and filing fees and suggested the Alliance review their status in all states to ascertain whether there are states where no new business is being written and whether it would not be wise to withdraw in

It we properly moved and seconded to accept the accountant's report. Motion carried. President Mack returned and assumed his

position as Chairman of the meeting.

He called on Mrs. Florence Eckert for her Garsas report.

Mrs Eckert noted that at the 1987 meeting of the Board a motion was approved to make certain changes in the Garsas and to have the publishing transferred from Brooklyn to a closer location to the Home Office.

Mrs. Eckert presented the Board with a breakdown of certificates in force according to age and noted the results showed we should concentrate on increasing memberships especially in the younger age groups. She pointed out that this is the direction she has been working in.

During this past year she was invited to speak at the Junior and Senior classes of the local High School and noted the students proved to be a captive audience with a great interest in the subject of the Baltic States.

The Garsas received national recognition when the Associated Press picked up a local feature on our publication and it was carried in newspapers in cities and towns all over the country.

Mrs. Eckert notes that our subscriptions outside of the membership rolls have increased at a rate of 5 to 1 and there is growing evidence that the young people are beginning to read the Garsas.

She submitted a few recommendations to the Board one of which was to Americanize the name of the publication. She suggested a contest before the next convention seeking names to be considered noting there aren't too many young people out there who want to say "I read it in the Garsas!" The name Garsas can be carried on the mast head in small print directly under the new name.



JAV VYSKUPŲ KONFERENCIJOJE SVARSTYTI IR LIETUVIŲ REIKALAI

(Washingtonas, 1988 lapkričio 17. LIC Jungtinių Amerikos Valstijų vyskupai, susirinkę Washingtone aptarti įvairius klausimus, vieningai priėmė pareiškimą, turinti daugiau kaip 60 puslapių, religinės laisvės Rytų Europoje ir Sovietų Sąjungoje klausimu.

Pareiškime pasisakoma apie religine padėtį kiekvienoje Rytų Europos šalyje. Aptariant Sovietų Sąjungos padėtį, daugiausia dėmesio skiriama Lietuvai ir Ukrainai. Pareiškimas apibūdina Lietuvos Katalikų Bažnyčią kaip tvirtovę prieš sovietų bandymus sunaikinti Lietuvos religinę, kultūrinę bei politinę tapatybę. Lietuvos Katalikų Bažnyčios Kronika padėjus atkreipti pasaulio dėmesį į Bažnyčios sunkią padėtį. Sovietų valdžia kalino ir kitaip vargino Kronikos, Lietuvos tikinčiųjų teisėms ginti kataliku komiteto bei Lietuvos Helsinkio grupės vadus. Kai kurievadai buvo fiziškai užpulti arba žuvo neaiškiom aplinkybėm.

Vyskupų pareiškimas atkreipia dėmesį į tai, kad vyskupui Steponavičiui trukdoma eiti Vilniaus apaštalinio administratoriaus pareigas. Kritiškai pasisakoma apie valdžios politiką ryšium su kunigų skaičiaus apribojimu, vaikų katekizacijos draugimu, antireligine propaganda ir t.t.

Taipgi atkreiptas dėmesys į teigiamus reiškinius paskutiniu metu Lietuvos katalikų religiniame gyvenimea, įskaitant vyskupo Sladkevičiaus pakėlimą į kardinolus, Kauno kunigų seminarijos studentų skaičiaus padidinimą bei sovietų valdžios pažadą tikintiesiems sugarąžinti Vilniaus katedrą, Šv. Kazimiero bažnyčią ir Klaipėdos Taikos karalienės bažnyčią.

Vyskupų pareiškimas pabrėžia, jog svarbu neužmiršti žmogaus teisių bei religinės laisvės klausimų, siekiant taikos ir ginkluotės apribojimo sutarčių su sovietais. Prieš religinių laisvių suvaržymą reikia parotestuoti, ir už persekiojimus tikinčiuosius melstis. Taipogi vyskupai skatina tikinčiuosius Vakaruose užmegzti ryšius su religinėm visuomenėm už geležinės uždangos, juos lankyti ir jiems teikti finansinę bei kitokią paramą.

Vyskupų konferencija taip pat atkreipia dėmesį į Pabaltijo valstybių ypatingą padėtį, pažymėdama kad Vatikanas, JAV bei kitos valdžios nepripažįsta jų inkorporavimo į TSRS 1940 metais.

Paskutinėje vyskupų sesijoje vykusiose diskusijose apie religinės laisvės dokumentą vyskupas Paulius Baltakis, OFM, ir Arkivyskupas Charles Salatka padarė pareiškimus, paremiančius siūlomą dokumentą ir apšviečiančius kitus vyskupus apie Lietuvos tikinčiųjų padėtį.

KUN. SIGITAS TAMKEVIČIUS SUGRĄŽINTAS Į LIETUVĄ

(Roma, 1988 lapkričio 7, LIC) Tarp 300 - 400 žmonių sutiko kun. Sigitą Tamkevičių Vilniaus geležinkelio stotyje anksti penktadienio rytą, lapkričio 4 d., praneša Lietuvių Informacijos Centro skyrius Romoje. Susirinko kunigai ir pasauliečiai, jauni ir seni, vyrai, ir moterys nešdami Lietuvos trispalves bei Vatikano dvispalves. Minia giedojo religines giesmes ir dainavo liaudies dainas. Jų tarpe susirinko ir buvę kaliniai: kun. Jonas Kastytis Matulionis, prieš dvi dienas grįžęs Viktoras Petkus ir Petras Cidzikas, kuris ką tik spalio 29 d. užbaigė savo 32 dienų bado streiką dėl Lietuvos politkalinių. Visi susirinkusieji nužygiavo prie Aušros Vartų koplyčios, kur kun. Tamkevičius tarė šiuos žodžius:

"Gruodžio 23 d. naktį, lydimas kareivių su vilkiniais šunimis, įsėdau į Stolypino vagoną. Gailestingumo Aušros Vartų Motinos paprašiau, kad palaimintų ir išvažiavau į Uralą. Prabėgo beveik šešeri metai, ir šį dieną man kaip sapnas. Tada negalėjau nė pagalvoti, kad bus šitokia diena kaip ši, kad tauta

bus atgimusi, kad Bažnyčioje bus daug vilčių, kad žmonėse bus toks entuziazmas. Tada atrodė viskas sukaustyta ledu.

O, tokiu pagrindu gali būti tiktai Dievas. Važinėdamas etapais iš Uralo į Mordoviją, iš Mordovijos į Sibirą, aš mačiau tūkstančius žmonių, tūkstančius

nužmogėjusių žmonių, baisių. Nesinorėjo nei būti jų tarpe, bet būti reikėjo, ir visi jie buvo tokie todėl, kad neturėjo Dievo. Jie jo galbūt niekada nepažino, jie neturėjo į ką atsiremti ir, nuėjo nusikaltimo keliu.

Padėka Jonui Pauliui II

Paskyrimas lietuvio kardinolo V. Sladkevičiaus yra didelės istorinės svarbos laimėjimas. Amerikos Lietuvių Taryba pasiuntė popiežiui Jonui Pauliui II padėkos laišką, pažymėdama, kad tuo labai džiaugiasi po visus kontinentus išbarstyti lietuviai, o ypač tai bus didelis sutvirtinimas pavergtai lietuvių tautai, vedančiai kovą dėl sąžinės laisvės.

Okupantas seka spaudą

Amerikiečių spaudoje pasirodančius straipsnius, laiškus seka Lietuvos okupanto įstaigos. Neseniai per Vilniaus radiją buvo užsipultas prel. J. Prunskis dėl jo vieno laiško išspausdinto "Chicago Tribune".

Garbė Jėzui Kristui! Kai lapkričio 4 dieną, sugrįžęs iš Sibiro tremties išlipau Vilniaus geležinkelio stotyje, tai ką pamačiau, atrodė lyg gražus sapnas. Pasitiko kunigai, bičiuliai, ir daug daug tikinčiųjų. Plevėsavo trispalvės, giedojome ir dainavome eidami į Aušros Vartus. Savo akimis pamačiau, kad Lietuva nebe ta, kokią ją palikaua 1983 m. gruodžio mėn., vykdamas į Uralo lagerį.

Žmonės tarsi pabudę iš ilgo miego ir sustingimo, į šitokią Tėvynę sugrįžti man buvo dvigubas džiaugsmas. Atgimimas Tėvynei ir Bažnyčiai teikia vilčių, kad turėsime ateitį.

Tačiau šiandien negalima gyventi iliuzijomis. Šviesesnė ateitis savaime neateis. Ją reikia išsikovoti. Šiame tautos atgimime Bažnyčią turi įnešti bene svarbiausią dalį. Nesupasavusio stalinizmo ir stagnacijos laikotarpiu Bažnyčia turi ypač padėti žmonėms dabar. Tautos atgimimas prasideda nuo kiekvieno lietuvio atgimimo — kada kiekvienas, tikintis Dievą ir netikintis dvasines vertybes pastatys aukščiau laikinųjų vertybių ir savo intereso.

Esu giliai įsitikinęs, kad tik Bažnyčia gali pakelti žmonių moralę. Tik Ji viena pajėgi rimtai ugdyti žmonių dvasingumą. Reikia tik pasidžiaugti, kad respublikos vyriausybė ieško kontaktų su Lietuvos Bažnyčios hierarchija ir kunigais, kad bendromis jėgomis gydytų tai, kas supuvo stalinizmo ir stagnacijos metais.

Dar nežinau, ar vyriausybė turės drąsos duoti pakankamai Bažnyčiai laisvės, kad ji galėtų atlikti savo misiją. Jeigu ta laisvė bus tik dalinė, tai rimtų rezultatų tikėtis negalima. Tačiau, bet kokių atveju, šiuo metu prieš Lietuvos kunigus iškilus didelė atsakomybė ne tik prieš Dievą ir Bažnyčią, bet ir prieš tautą. Reikia pakelti Lietuvą iš alkoholizmo. Reikia kovoti už sveikatą ir gausią šeimą. Reikia padėti tautiečiams nusikratyti stalinizmo pagimdytos baimės ir sustingimo.

Norėčiau visus Lietuvos kunigus ir tikinčiuosius paraginti į didelį žygį ir į didelę auką. Vardan Tėvynės ir Bažnyčios verta pavargti, verta pakentėti. Jei norime geresnės ateities, išsikovokime ją! (LIC)

Marčiulionis, A. Sabonis, R. Kurtinaitis, S. Chomičius, o laimėtą aukso medalį Maskva priskyrė sau. Kai portorikiečiai olimpiadoje pasiekė kokius laimėjimus, jie buvo užskaitomi Portoriko valstijai, o Maskva priskyrė sau, ne Lietuvai. Tokią informaciją Altas perteikė ir Tribune redaktoriams.

Lietuvių Teisėms Ginti Komiteto ir Fondo posėdyje, įvykusiame 1988 liepos 30 Chicagoje, dalyvaujant VLIKo atstovui Vytautui Jokūbaičiui, JAV LB atstovams dr. Viktorui Stankui ir Danguolei Valentinaitei bei ALT pirm. G. Lazauskui, ap-

svarstyti LTG Fondo tarybos ir valdybos papildymai.

Pasibaigus kadencijai, LTG Fondo tarybos pirmininkų išrinktas dr. Viktoras Stankus (iš Clevelando), LTG Fondo tarybos pirmininku — Vytautas Jokubaitis (iš Clevelando) ir LTG Fondo valdybos pirmininke — Danguolė Valentinaitė.

Amer. Lietuvių Taryba buvo išleidusi keturias laidas prel. dr. J. Prunskio knygutės "Lithuania". Iš viso jos tarp amerikiečių paskleista apie 80,000, tačiau ir dabar yra gausus pareikalavimas. Dabar leidžiama nauja papildyta penktoji laida.

Prieš marksistinę priespaudą

Kongresmanas Edward F. Feighan atsiuntė ALTo pirm. Gr. Lazauskui raštą, pranešdamas apie naują priespaudą Rumunijoje, kad iš jos pabėgo net apie 30,000 vengrų. Kongr. Feighan pranešė, kad net 200 kongresmanų pasirašė laišką JAV Valstybės departamento sekr. George Shultzui prašydami paveikti, kad tie piktnaudojimai Rumunijoje pasibaigtų.

Feighan pažymi, kad prieš 30 metų Vengrijoje buvo nužudyta apie 2,000 sukilėlių — laisvės kovotojų ir iki šiol jų giminėms neleidžiama atrasti artimųjų lavonus ir juos deramai palaidoti. Tą reikalą kongresmanai dabar priminė naujajam Vengrijos ministeriui Karoly Grosz.
